

## The Moorings Auckland On Water Boat Show Visitor Survey

### OFFICIAL RULES

#### **NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.**

#### **A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

The Moorings "Auckland On Water Boat Show" Visitor Survey ("Survey") begins at 10:00 a.m. (NZST) on 3/10/2019 and ends 6:00 PM (NZST) 6/10/2019. Survey consists of one draw. To qualify for the draw, entries must be received during the time frame as specified above. Survey winner needs not be present to win the prize.

**ELIGIBILITY:** Survey is open to all Auckland On Water Boat Show attendees who are 18 years of age or older at time of entry. Persons who are employees of The Moorings (the " Sponsor"), its respective parent companies, affiliates, subsidiaries, agents and the immediate families (spouse, children, parents and siblings) and/or those living in the same household of such persons at any time before or during this Survey are not eligible to enter.

**GRAND PRIZE:** The Grand Prize winner will receive one 7-day charter departing from The Moorings base in Vava'u, Tonga and airfare from Auckland International Airport to/from the point of embarkation for two (2) guests. Values noted herein are not based on and are not valid over peak season from 27 Jun – 4 Aug; 19 Sep – 31 Oct and do not include airport transfers, crew, provisioning or accommodation. Grand Prize awarded as a gift certificate to the winner featuring the specific details of the charter. Bareboat Yacht Charter: ARV: \$6,378 -\$7,758. Trip includes: 6 nights/7 days onboard a Moorings or Sunsail Branded approximately 43' catamaran or similar including damage waiver insurance. ARV of each trip prize depends on the selected charter dates and rates at time of departure. Airfares: ARV: \$1416 -\$3312.
